This has reference to your application No. Nil dated 29th October 2012 and subsequent letter dated 7<sup>th</sup> July, 2014 requesting permission for affiliation of a new Shree Jaya Anand Commerce & Science Night Degree College to conduct (1) B.Com. (A & F) and (2) B.Sc. (I.T.) courses proposed to be started at Charai, Beside Dr. Kumbla Hospital, Thane(W) from the academic year 2014-15 alongwith copy of above referred G.R. and Certificate.

In this connection, I am directed to inform you that considering the permission granted by the above mentioned authorities to your Foundation, I am pleased to inform you that your Foundation has been granted permission for first time affiliation to start new Night College in the name of Shree Jaya Anand Commerce & Science Night College proposed to be started at Charai, Beside Dr. Kumbla Hospital, Thane(West) on permanently "No Grant Basis" permanently as Night College to start (1) B.Com.(A. & F.) and (2) B.Sc.(I.T.) degree course with intake of 60 students in each division from the academic year 2014-15.

The college has to fulfill the condition mentioned in the above referred Government Resolution and also to fulfill the following affiliation conditions:-

- 1) That the conditions laid down by the University from time to time.
- 2) That the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- 3) Admissions should not be linked with donations.
- 4) That the college will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No. Aff./Recog./49 of 1987, dated 4<sup>th</sup> February, 1987 (copy enclosed).

- 5) That college should follow the norms as prescribed and circulated by the University vide No. CONCOL/75 of 1988, dated 3<sup>rd</sup> March, 1988 (copy enclosed).
- 6) The college shall not admit the students over and above sanctioned intake.
- 7) The college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.
- 8) That the college should submit certificate from the Joint Director to that effect.
- 9) That the college will apply within one year after completion of five years for NAAC accreditation and if college not apply for accreditation the affiliation of college will automatically stand cancelled.
- 10) If, it is observed that 50% or less students admitted as per sanctioned intake the action of de-affiliation will be initiated against the college by the University.

Further, enclosed herewith are the copies of the Circulars No. Aff./Recog./ICC/2012-13/17 dated 24<sup>th</sup> August, 2012 and No. Aff/Recog.I/189 of 2008, dated 17<sup>th</sup> May, 2008 for your information and further necessary action.

In case you could not start the College from the academic year 2014-15. the permission granted to your Trust will stand cancelled, which may please be noted.
