 - However, when no notice of one month is given by you, you will be required to deposit an amount equal to one calendar months' salary along with your written application / resignation, in such an exceptional event, the Management shall be at liberty to refrain from issuing any certificate including your service certificate.
8. The appointment is a full time one and does not permit the holder to engage himself/herself in any outside business, consultation, professional, tutorial and-or such other outside work either with or without remuneration without the express sanction of the College.
9.
